#### Agenda Item 1 - Welcome & Introductions

## **Agenda Item 2 - Transcript from February 24, 2021 FSSB Meeting** (Transcript, P.7)

Mr. Grgurina asked if there were any changes to the February 24, 2021, FSSB meeting transcript. Motion to approve transcript by Dr. Larry deGhetaldi, seconded by Dr. Ted Mazer. The Board approved the February 24, 2021 transcript.

#### **Agenda Item 3 - Department of Health Care Services Update** (Transcript, P. 7-34)

René Mollow, Deputy Director for Health Care Benefits and Eligibility at the Department of Health Care Services (DHCS), provided an update on the Medi-Cal Rx project, telehealth, and the department's response to COVID-19.

#### Agenda Item 4 - Director's Remarks

Director Mary Watanabe discussed the Department's organizational changes which included her confirmation as Director as well as the appointments of Dan Southard as

the Chief Deputy Director, Rachel Long as Deputy Director of the Help Center, and Nathan Nau as the Deputy Director of the Office of Plan Monitoring. Ms. Watanabe provided a brief overview of the health care related items in the Governor's May revision to the budget. She also provided an update on the Health Equity and Quality Proposal and the Department's response to COVID-19.

Ms. Dutt presented an update on the financial status of health plans for the quarter ending December 31, 2020.
